EMS AGREEMENT

Commercial Township Fire District 3;

WHEREAS, Commercial Township Fire District 3 is in need of various first aid services concerning the volunteer firemen responding to the scene of a fire and relative to individuals residing within the fire district: that of first aid services to individuals of the fire district; and

WHEREAS, the Laurel Lake Fire and Rescue Co., Inc. EMS Division (EMS Squad) is desirous of providing said services pursuant to the terms and conditions hereinafter set forth;

NOW, THEREFORE, it is agreed between the parties as follow:

1. When the fire company is dispatched to a fire scene, the EMS squad shall respond to the fire scene with the appropriate ambulance and crew for the purpose of providing first aid services to the fire company volunteer fire fighters at the scene. The only fire incidents to which the EMS squad shall respond is structural fires, extrications, second alarms fires, motor vehicle crashes, and when otherwise requested by the fire company.
2. The fire district shall also receive first aid services to the people that fall under their districts accordingly. This shall consist of all emergency responses dispatched per the 9-1-1 system by the Cumberland County 9-1-1 Dispatch Center for said fire district.
3. The fire district shall receive from the EMS squad, quarterly and at year-end, written reports setting forth the total number of responses and the number of responses by each of the EMS squad personnel\members responding to each fire incident or emergency first aid calls within your set district.
4. The fire district shall have the right to request and receive from the EMS squad a year-end audit relative to the monies paid hereunder.






5. The EMS squad shall receive set amount of \$14,000 from Fire District #3 paid quarterly That amount would be \$3,500 for providing the services set forth herein. The EMS squad shall submit a voucher to the fire district for review and approval by the fire district in order to receive the appropriate monies.



The term of the agreement shall be for one (1) year from the date of the execution of the agreement and shall continue on a year-to-year basis unless either party submits in writing a letter seeking to terminate the contract within thirty (30) days before its year-end anniversary. This contract will herein take effect January 1, 2025.


