Correspondence

- Eurofins Environmental
 - Wanted to know if we would like to move to monthly total coliform testing since NJ Water Watch has our testing listed as monthly (currently quarterly)
 - Per Robert Welch this is probably because the State Trooper Barrack's well failed a test
 - Had an issue accessing the building in September
 - Tried again the following week without an issue
 - Per Kacy it the responsibility of Laurel Lake Volunteer Fire and Rescue, we will leave it alone unless there is another problem

- LOSAP
 - Back and forth with Lincoln, no progress
- Truck payment

- Exterior lighting
 - Deerfield electric fixed lights under front overhang
- Ice machine
 - Installed
- Building insurance claim

 - Price increased drastically, including competitors

New business

- Damage to Bay door
 - Ambulance backed into door
 - Quotes received from Elmer door and south jersey door
 - 4400 and 3600 respectively
 - Unable to find a third company to give a quote
 - Ambulance is stuck in bay since the door cant be opened
 - Motion made by John Reeves to have SJ door fix the door, seconded by Janet Campbell
 - Larry Coffman in favor, Kacy Catalano abstained Dave Carangi absent
- 1301 was in a collision
 - Information from the vehicle struck was not obtained

- Finalize budget as decided in October 2025
 - Resolution #11092025 – commissioner compensation
 - All present in favor, Dave Carangi absent
 - Motion made by Larry Coffman, Seconded by John Reeves, Kacy and Janet in Favor, Dave Carangi absent
- SCBA bottles
 - 15 bottles will be beyond manufacture's 15-year service life by 2028
 - Considering reducing the total number of bottles to avoid using capital outlay
 - Using capital outlay to by SCBA packs
 - Ray Klecz to get a new quote

 - Eight calls for the month
 - Tender
 - Door alarm malfunction
 - Ladder rack is malfunctioning
 - Will have Campbells come out to inspect
- EMS
 - Need information from the commissioners regarding ambulance maintenance
 - Will cross reference invoices and meeting minutes
 - All ambulances need oil changes
 - 1326 needs the auto ejector replaced – issue with charging stretcher battery
 - 1330 needs to be inspected, registration needs to be renewed, and the brakes need to be serviced, currently being decontaminated
- Training
 - Planning on switching to Fire One for both Fire and EMS training
